Party Singers is Concerned About Its Former Managers Heather Lacy and Sarah Lippa

Party Singers Wants to Avoid Further Confusion with Newly Formed "The Denver Dolls"

Denver, CO: Lucky 15 LLC dba Party Singers has found that Heather Lacy and Sarah Lippa are now using its confidential company information to pursue Party Singers' client relationships to serve their new company. Party Singers' groups, "The "Company B Gals" and "The Beverly Belles" have been directly copied by Lippa and Lacy to create "The Denver Dolls".

Party Singers and its "Beverly Belles" and "Company B Gals" are in no way affiliated with "The Denver Dolls", nor does Party Singers support Lacy and Lippa's new group.

Lacy and Lippa worked for Party Singers as managers from 2013, 2014 and 2015. They also performed as singers in Party Singers' groups: "The Company B Gals", "The Mistletoes", "Absolute Noel" and "Absolute Romance" in 2013, 2014 and 2015. Lacy and Lippa had access to confidential information and trade secrets of Party Singers, and received extensive training by Julia Tobey, Party Singers Owner. They received important information such as financial records, client lists, talent pools, business plan and concepts. Lacy and Lippa had agreed not to use this information outside of Party Singers' operation.

As Party Singers Sales Manager in 2015, Lippa had several exchanges with Party Singers' clients assuring them to look out for Party Singers' new Andrews Sisters group in 2016. That group is Party Singers' "The Beverly Belles", established in Hollywood in 2014, new to Colorado as of 2016. It appears that "The Denver Dolls" are obtaining business based upon Lippa's representations to Party Singers' clients. This is disappointing to Party Singers.

Lacy and Lippa have caused confusion as to whether or not they are still associated with Party Singers and its trade names. Their group, "The Denver Dolls", does in fact duplicate the group they helped create and performed with under Party Singers.

"The Beverly Belles" signature look was recently copied exactly by "The Denver Dolls". **See photo below.** Their musical repertoire is almost identical to "The Beverly Belles" as well.

Party Singers' loyal clients and colleagues have expressed confusion.
